Receive the Holy Spirit!

Do you know and experience in your own life the gift and power of the Holy Spirit? After his death and resurrection Jesus promised to give his disciples the gift of the Holy Spirit. He said to them, *Receive the Holy Spirit! (John 20:22)* Jesus knew that his disciples would need the power of the Holy Spirit to carry out the mission entrusted to them. The gift of the Holy Spirit was conditional upon the ascension of Jesus to the right hand of the Father. That is why Jesus instructed the apostles to *wait in Jerusalem until you are clothed with power from on high (Luke 24:49)*.

Why did they need *power from on high*? The Gospels tell us that Jesus was filled with the Holy Spirit when he was baptized at the Jordan River: "And John bore witness, 'I saw the Spirit descend as a dove from heaven, and it remained on him... this is he who baptizes with the Holy Spirit'" (John 1:32,33; Mark 1:8; Matthew 3:11).

Just as Jesus was anointed with the Spirit at the beginning of his ministry, so the disciples needed the anointing of the Holy Spirit to carry out the mission entrusted to them by Jesus. The Holy Spirit is given to all who are baptized into Jesus Christ to enable us to live a new way of life - a life of love, peace, joy, and righteousness (Romans 14:17). The Holy Spirit fills our hearts with the



love of God (Romans 5:7), and he gives us the strength and courage we need in order to live as faith-filled disciples of the Lord Jesus.

Isaiah foretold the seven-fold gifts that the Spirit would give: wisdom, understanding, counsel, fortitude, knowledge, piety, and fear of the Lord (Isaiah 11:2).

The gift of Pentecost - the outpouring of the Holy Spirit, and the spiritual gifts and blessings of God - are made possible through the death, resurrection, and ascension of the Lord Jesus.

History 2018 - 1922

He was elected on September 19, 1914, and served through WWI. His successor, Pope Pius XI was elected on February 12th. 3) A Chippewa Indian from Cass Lake, MN, believed to be the oldest living human, died on February 7th, at the ripe old age of 137. As for that birth, Judy Garland (born Francis Ethel Gumm), of 'Wizard of Oz' fame, was born on June 10th, in Grand Rapids, MN.

Here's one for the sports fans: The Rose Bowl on New Year's Day ended up in a 0-0 tie between the University of California and Washington and Jefferson College. How do you split the trophy in half? (Must not have had a plan in place for this eventuality.)

That publication of condensed articles, the Reader's Digest, hit newsstands for the first time on February 5th.

The governing body in Honolulu created a policy that Waikiki beach goers were required to wear clothes. We were there twice, in 1969 and again about 1982, and I'm sure they were all wearing clothes. That's not something you would easily forget!

With prohibition in place the death rate due to alcohol was down 21%. Do the math with me here and we see a death rate of 79% yet, which means there were lots of people who disregarded the law. But, never fear the Feds are here! They decided to crack down on people having hip flasks in restaurants and dance halls and made it illegal for any ship with alcohol on board to enter a U.S. port. That meant most shipping went north to Canada. Mom had a saying for actions like that, 'that's cutting off your nose to spite your face'.

And finally, Miss America contestants were not allowed to use sweet smelling perfumes, powders or flowers, because they might sway the judges. (Only if they were blind, in my estimation.) Okay, don't yell at me, I'm ready to leave anyway, 'cuz my time is up! See ya' next month.
